

QIWI Announces Extraordinary General Meeting of Shareholders

Shareholders are cordially invited to attend the EGM.

At the EGM, the following items will be submitted for shareholders' approval:

- 1. approval of total amount of shares to be reserved for issuance under the 2015 Employee Restricted Stock Units Plan;
- 2. approval of the 2015 Employee Restricted Stock Units Plan.
